ANNUAL GENERAL MEETING HELD ON 18 MAY 2018**

The Board is pleased to announce that all ordinary resolutions proposed at the AGM were duly passed by way of poll.

Reference is made to the circular (“**Circular**”) of Stella International Holdings Limited (“**Company**”) dated 11 April 2018. Terms used herein shall have the same meanings as defined in the Circular unless the context requires otherwise.

POLL RESULTS OF THE AGM

Pursuant to Rule 13.39(4) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited, the voting of all resolutions proposed at the annual general meeting (the “**AGM**”) of the Company held on 18 May 2018 had been taken by poll.

As at the date of the AGM, the total number of ordinary shares (“**Shares**”) of HK\$0.10 each in the issued share capital of the Company was 794,379,500 Shares, which was the total number of Shares entitling the holders (“**Shareholders**”) to attend and vote for or against all resolutions proposed at the AGM. There was no restriction on any Shareholders casting votes on any of the resolutions proposed at the AGM.

The Company’s Hong Kong share registrar, Computershare Hong Kong Investor Services Limited, was appointed as the scrutineer at the AGM for the purpose of vote-taking.
